- I. Call to Order and introduction of guests: Meeting was called to order by Chair, Judie Mueller (Webster Postmaster). - **II. Review of December 8, 2015 Minutes** Dan McCormic was excluded from attendance in minutes. Martin Steele made a motion to approve and Kelly Williams 2nd. Approved with the change presented.
- **III. Treasurer's Report**-Beginning Balance as of 12/1/15 is \$1,875.67. Ending balance as of 12/31/15 is \$2,400.77. Deposits of 425.10 from Antique Appraisal Fair and 100.00 from Cash Box for Fair. No Expenditures. 2016 Budget to be presented next month for approval. Rich Baier made a motion to approve; Kelly Williams 2nd. Approved as presented.

 - **A.** Organizational Sustainability-Discussion of the rough draft letter that Mike presented to go out to members that have not been coming to meetings to try and create an interest since we have been designated. Changes were made and will present to Marketing Committee.
 - **B.** Coast to Coast Connector Update-Kelly reported that there is a change to the date of the PAG meeting, as it will now be held beginning of March. There is a Greenways Trail Foundation meeting that evening that Kelly and Rich Baier are planning to attend. Sumter and Pasco counties plan on having separate public meetings to discuss proposed trail alternatives. Was also indicated that there was an article on the coast to coast in the Daily Sun around the 13th of the month, along with an article featuring Bradley Arnold's work anniversary.
 - **C.** Transportation Alternative Program-Dawn submitted the FDOT Project application to Pamela Richmond at MPO who will present to Sumter County. Rich Baier had not seen the application come through as of the beginning of the week.

A. Kiosks-Louis Reis, the FDOT Engineer, along with Mike Palozzi, Rich Baier, Jackey Jackson met at the Rutland County Park to go over the location options. Louis expects to have a rendering drawing and plans available by the end of January. The County

- **B.** Donor Brick Program-Dawn working on a brochure to start the donor brick campaign. Pricing will be \$50.00 for a 4x8 and \$100.00 for an 8x8 brick. Was suggested to get a Brick Disclaimer from the Veteran's Affairs Office.
